The League had a balance of \$34,126 as of May 14. April expenses totaled \$5,723. April income totaled \$695. The league is considering switching its account from Bank of America to Compass Bank to avoid what appear to be excessive fees being charged by the former.

**A. RANDOLPH SOCCER CLUB DONATION**

PCJSL has donated \$20,000 to the effort to light the two fields at Quincy Douglas. Contingent on the COT committing to the project, this clears the way for the \$5,000 committed by the TMSL to be released.

**B. SUMMER SEASON REGISTRATION**

A total of 28 teams registered for the TMSL summer season. This includes 10 teams in "A" Division, 12 in "B" Division, and 6 in the Over 45 Division.
