

**MINUTES  
TUCSON METRO SOCCER LEAGUE BOARD MEETING  
MAY 5, 2010**

Call to Order at 6:40 p.m.

**I. MINUTES:**

The minutes from the April meeting were approved.

**II. TREASURER'S REPORT:**

As of May 4, the League had \$18,061 in its accounts, \$7,225 in checking and \$10,806 in the money market account. April income was \$5,080. Expenses (cleared transactions) in April totaled \$7,577 with an additional \$1,092 in uncleared transactions.

**III. OLD BUSINESS**

**A. SUMMER REGISTRATION**

Currently, 14 teams have submitted registrations on-line (4 Premier, 8 D1, and 2 O45). Another email will be sent out reminding previously registered teams of the May 13 deadline.

The office needs to be manned on the following dates by BOD members to assist teams with completing their registration. May 12 (Brad and Eddie), and May 13 (Brad, Eddie, Marty, Pip, Carl, and Steve). Additionally, BOD members will have to present on May 27 for distribution of team packets. Cynthia will let us know the level of volunteers needed between these dates to assist in preparation of the player passes.

Teams from the recently completed regular season need to turn in all of their player passes.

**B. GAME ROSTER FORMS**

A plan to require official game rosters to be printed from the registration website was discussed. Under this scenario, the referees would not accept hand-written roster forms. The discussion included whether this method, in conjunction with the presentation of other official picture ID, could be used to preclude the use of player passes (although this is in conflict with the current ASSA By-Laws).

A motion to require the use of these printed rosters during the upcoming summer season (along with presentation of valid player passes) was passed.

**C. ON-LINE REGISTRATION AND ASSA SYSTEM COORDINATION**

John Farmer and Eddie Suh met with Cynthia to attempt to resolve issue that have come up when working between the On-line registration system and the ASSA database used to create the player passes among other things. Reports indicate the meeting went well but neither Eddie or John was available to attend the BOD meeting.

Adam will speak with them and have them report to the BOD on any progress that was made.

**IV. NEW BUSINESS**

**A. OFFICER ELECTIONS**

TMSL officer elections will be held at the June meeting. Brad has announced his intent to step down as Secretary at that time. Any BOD members who are interested in filling that or any officer position should email Carl.

**B. FIELD USER GROUP MEETING**

The City of Tucson will be holding a Field User Group Meeting for the fall/winter time frame at the Randolph Park Clubhouse. This is an informational meeting about how to obtain fields from the City Parks and Rec. Dept.

**C. REPETITIVE RED CARD OFFENDERS**

Discussed the need for stronger sanctions on players who repeatedly receive red cards. By-law changes to address this issue will be discussed at a later date.

The meeting was adjourned at 7:46 p.m.
